

## **Privacy policy.**

This privacy Policy (the "policy") applies to all information that LLC "Travelline Group" (further – the Statement for processing personal data or PD operator), can get about the user in the process they use the "leave feedback" form. The PD operator guarantees the confidentiality of all information entered the user in the process of using the Form.

## **Use the term.**

The following terms are used in this Policy:

User's personal information – data that the user enters into the special fields when using the Form: surname, first name, patronymic, e - mail address, registration city...

Means of accommodation-premises used for the provision of reception services and accommodation of guests.

A cookie is a small piece of data sent from a web server and stored on the computer of the user that the web client or web browser sends each time the web server in the HTTP request when you try to open the page of the corresponding site.

IP-address-a unique network address of a node in a computer network built by IP.

## **Generalities.**

The User's use of the Form constitutes acceptance of this Policy privacies.

In case of disagreement with the terms of the privacy Policy, the User must stop using the Form.

PD operator does not verify the accuracy of the user's personal information, user-provided Form.

## **Purpose of personal data processing, use and disclosure of personal information.**

In the process of using the Form, the User independently enters in the special designated fields the user's Personal information than gives its consent to collection, systematization, accumulation, storage, clarification (update, change), use, transfer of personal data to the Partners of the Operator. Hereby the consent is provided by the User for the implementation of any non-conflicting to the legislation of the Russian Federation of actions concerning personal information of the User, aimed at achieving the specified in this Policy objectives, reporting and accounting documentation. Personal information of the Form user is used by the PD Operator solely for the purpose of obtaining feedback on the quality of the funds provided accommodation services. The data provided by the User are used solely for the purpose of providing effective, comfortable and convenient service using the Form, as well as for evaluation quality of services. PD operator does not sell, transmit or otherwise disclose to anyone user's personal information without User's consent.

## **The use of Cookies.**

In order to provide quality services, the PD Operator stores Cookies on the user's computer and subsequently uses them.

The operator of personal data guarantees that none of the advertising service does not have access to the files Cookies, which are used in the process of working with the Form. PD operator records information about the user's IP-address, browser type, used by the User, which can be used in the detection of errors in the Form, fraud, unauthorized actions.

#### **The ability to edit and delete information and personal setting.**

The user can at any time change (update, supplement) the provided them personal information or its part. To do this, contact the Operator PD by sending an email to [sites@travelline.ru](mailto:sites@travelline.ru). The user can apply to the PD Operator with a request to delete his / her personal account. information from the database of the operator PD, contacting him at the above contacts.

#### **Measures taken to protect personal data.**

The PD operator accepts the necessary and sufficient organizational and technical measures to protect the user's personal information from illegal or random access, destruction, modification, blocking, copying, distribution, as well as other illegal actions with it by third parties. PD operator stores personal information of users in accordance with internal regulations of the Form, thus, concerning personal information the user's privacy is preserved.

#### **Changes to the privacy Policy.**

#### **Applicable law.**

PD operator reserves the right to make changes to this Policy privacies. When making changes in the current edition of the date specified latest update. The new version of the Policy comes into force from the moment of its placement, unless otherwise provided by the new version of the Policy. To this Policy and the relationship between The user and the PD Operator, arising in connection with the application of the privacy Policy, subject to application of the law of the Russian Federation.
